# 1. \$45,000 Earmark Request for ADA Improvements at Sweetsir and Donaghue Schools sent to Representative Mirra and Senator Dizoglio

Earmark was received and once the grant contract is received the COD chair will send it to the Board of Selectmen for approval.

Brienne Walsh made a motion to authorize Christopher Gaudet to send the grant contract to the Merrimac Board of Selectmen for approval once it is received.. Margaret Sullivan seconded the motion. Members unanimously accepted the motion.

# 4. Deaf Inc. Information Sheet (Update from Brienne Assisted Listening Devices

Brienne Walsh reported that Deaf Inc. will send a sample listening device for her to trial within the next two weeks. She also shared the Our Neighbors' Table offers interpreter services and will share information with her. The Massachusetts Commission for the Deaf and Hard of Hearing has a website with price lists for interpreters but the wait time is up to three months. Jeremiah Murphy shared that the Veterans' Administration often works on getting services for veterans. Many veterans have hearing issues and/or tinnitus and have needs for services and equipment. The Veterans's Administration helps with applications for phones with captions that are federally funded.

#### 5. MOD Grant

Christopher Gaudet provided updates on the MOD Grant. If the COD applies for the grant to complete the sidewalks on Church Street, there may be issues meeting the June 30 timeline because these are engineering issues that need to be addressed. Christopher Gaudet reached out to Robert Sinibaldi regarding relocating the sidewalk project to a different section of town but has not heard back yet. Grant needs to be submitted by the end of September so the COD will apply for a \$100,000 grant for new sidewalks on Union Street Extension and Locust Street. A \$45,000 grant will also be applied for for new sidewalks in a location to be determined by COD and DPW. Christopher Gaudet will reach out to Robert Sinibaldi again regarding sidewalks to be replaced..

### Agenda Items: No. V

 Meeting with Sweetsisr and Donoghue School's Principal Stephanie Dembro and Assistant Principal Krista Niles to review ADA Transition Plan and to Discuss \$45,000 Grant for ADA Improvements

Meeting was productive and school administrators were receptive. They showed good understanding of the plan and custodians will begin to work on no cost items now through next summer.

COD members discussed having an article written by John Guilfoil's company to let the public know about the COD and projects that have been funded through grants and earmarks. Margaret Sullivan shared information from CODA. Scholarships may be available.

Jeremiah Murphy from the VA shared that in 2020-21 there were 80 disable veterans in Merrimac. He explained that the VA works to connect veterans with health care services needed in addition to service covered by health insurance. They link veterans with health care options and try to do outreach through the Council on Aging so members are aware of resources that are available.
