Van/NEET Rides-Ordering Meals Fall Foliage Trip

Continuing Changes in Senior Center Operations:

Van and NEET Transportation:

8 clients per ride will be allowed on the van to go on van trips. NEET rides are 1 per car.

- 1. Client encouraged to wear a mask
- 2. Client must use Sanitizer Gel before boarding the van.
- 3. The Driver cannot assist the client boarding or de-boarding the van/car.
- 4. Donation for ride should be place in envelope and placed in basket driver will have place on seat behind him/her for your convenience.
- 5. The van will be sanitized after each ride and before another passenger embarks.
- 6. Call well in advance (at least 4 business days) for a ride as we are limited in our ability to offer rides.

A. Eligibility requirement:

- a) Clients must be able to self-transport from their home to the vehicle, enter and exit the back seat. Walkers and Wheelchairs must be done by client only, not the driver.
- b) Clients must be able to buckle their own seat belt.
- c) Clients must return signed NEET registration/guidelines form prior to transportation.
- **B. Prescreening:**

COA scheduler must ask pre-screening COVID-19 questions prior to appointment.

Please mail in your payment by check or leave envelope taped to your door. ,Food will be left at the door if no one is at home. Meals are \$5.00 per meal, \$25/ per week (as of 5/2/22).

<u>Greeting from your Public Health</u> Nurse!

I can't believe it is already October! Fall is a wonderful time of year to enjoy the cooler air and to spend time outside. However, along with falling leaves and pumpkins, this time of year also marks the beginning of respiratory virus season.

The 3 main viruses that we are thinking about during this time of year remain the same – COVID, Influenza (flu) and Respiratory Syncytial Virus (RSV). Fortunately, we have vaccines for each of these viruses that can provide protection from severe disease and can help prevent hospitalizations.

The FDA approved and authorized the 2024-2025 COVID vaccines on August 22, 2024. The COVID vaccine has been updated to reflect the most commonly circulating variants. The CDC recommends that everyone ages 6 months and older get an updated vaccine to help protect from severe disease, hospitalization, and death. It is especially important to get your 2024–2025 COVID vaccine if you are ages 65 and older, are at high risk for severe COVID, or have never received the vaccine. Vaccine protection decreases over time, so it is important to stay up to date with your COVID vaccine.

To review, the CDC released updated guidance last spring for people who test positive for COVID. The new guidance brings a unified approach to addressing risks from a variety of respiratory viral illnesses, including COVID, flu, and RSV. They recommend that when people get sick with a respiratory virus, they stay home and away from others. For people with COVID and flu, treatment is available that can lessen symptoms and lower the risk of severe illness. If you develop symptoms of a respiratory virus, it is important to test yourself so that you can get treatment and protect others in your community from getting sick. The recommendations suggest returning to normal activities when, for at least 24 hours, symptoms are improving overall, and if a fever was present, it has been gone without use of a fever-reducing medication.

Once people resume normal activities, they are encouraged to take additional prevention strategies for the next 5 days to curb disease spread, such as taking more steps for cleaner air, enhancing hygiene practices and wearing a well-fitting mask. Free at home COVID test kits are available at the Merrimac Senior Center and at Town Hall. Please stop by to grab a box!

Next up is the flu vaccine. Influenza (flu) is a potentially serious disease that can lead to hospitalization and sometimes death. It is recommended that everyone ages



6 months and older receive a yearly flu vaccine because immune protection from vaccination declines over time. Also, similar to covid, the flu viruses are constantly changing. Vaccines are updated to protect against the viruses that research indicates will be most common during the upcoming flu season. Getting vaccinated by September/October is ideal, though vaccination is recommended for as long as the flu is circulating during the season. Thank you to those who came to the flu vaccine clinic held at the Merrimac Senior Center on October 4th!

Lastly, we will review RSV and RSV vaccine. Respiratory syncytial virus, (RSV) is a common respiratory virus that infects the lungs, but can also affect the nose and throat. RSV does not usually cause severe illness in healthy adults and children. However, adults ages 75 and older, adults with chronic heart/lung disease, adults with weakened immune systems and those living in nursing homes/long-term care facilities are at greatest risk for severe disease.

CDC recommends an RSV vaccine if you are ages 75 or older or if you are ages 60-74 and have a risk factor for severe RSV disease. RSV vaccine is not currently an annual vaccine, meaning older adults do not need to get a dose every RSV season. That means if you have already gotten an RSV vaccine, you do not need to get another one at this time. Eligible adults can get an RSV vaccine at any time, but the best time to get vaccinated is in late summer and early fall. This timing ensures you're protected by the time RSV starts to spread in your community and ensures you get maximum protection during the winter months.



Dear Veterans & Families:

As we previously discussed in the last newsletter, Governor Healey signed into law the HERO Act on August 8, 2024. On



September 10th, staff from the Veteran Services Office attended a briefing with the Massachusetts Executive Office of Veteran Services (EOVS) Legal staff. One of the biggest changes in the Act is the definition of Veteran for local and state benefits received through EOVS. These benefits include the Chapter 115 financial assistance program, the Massachusetts Gold Star Annuity, access to Massachusetts Veterans Homes and Motor Vehicle fees to name a few changes. There are a number of other changes that are meant to expand the number of Veterans receiving state benefits and correct state regulations to align with current practices.

The EOVS change in the definition of Veteran will affect many Veterans that have served in the Guard or Reserves who didn't qualify for EOVS benefits in the past. Those Guard and Reserve Veterans who have a service-connected disability or completed a period of activation may now be eligible for the various EOVS Veteran benefits. If you are a Veteran of the Guard and Reserves or a widow(er) who has not remarried, you should contact the Veteran Services Office to review your eligibility.

One of the changes that did not make it int the HERO Act is the waiving of fees for a Veteran license plate; however, this change has been added to the Governor's supplemental budget. We will advise you if and when this change is approved.

We have already started planning for our Annual Veterans Day luncheon which will be held on November 8th. The luncheon is for any Veteran of any age who resides in our Veterans District, which includes the communities of Amesbury, Merrimac, Newburyport and Salisbury. As we get closer to the date we will provide more information.
